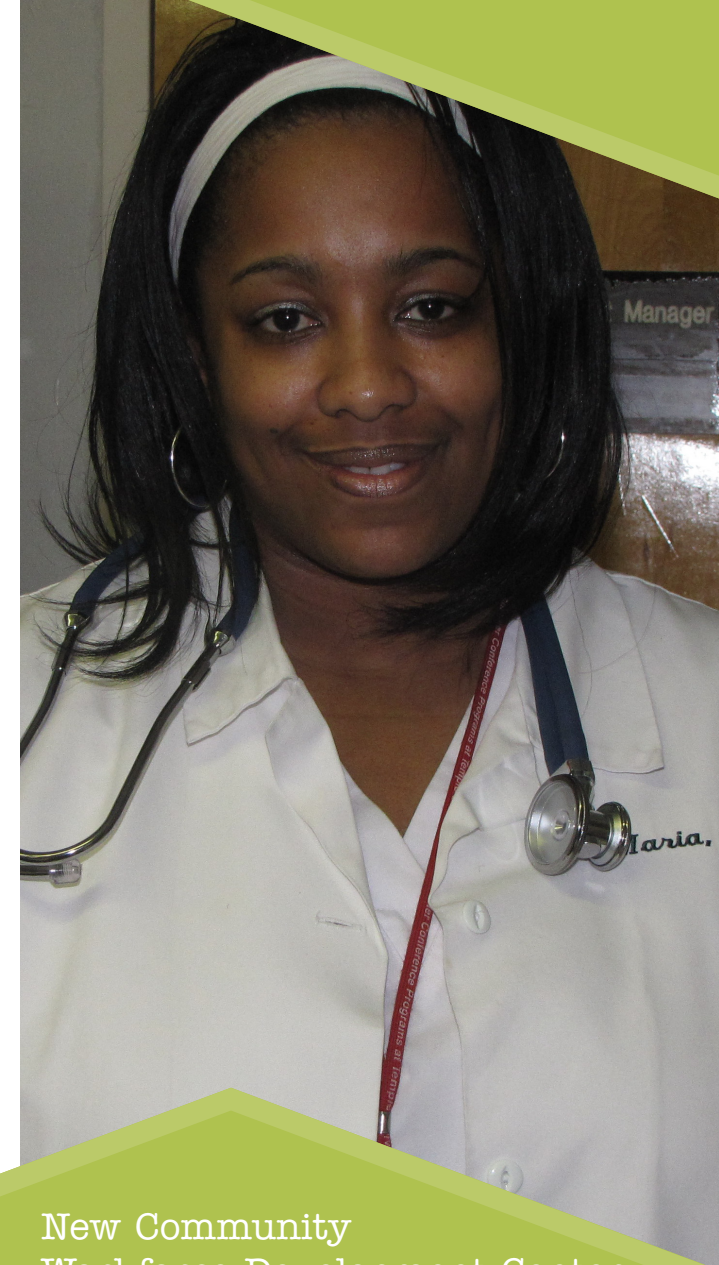
- Education and training courses

A Career In Nursing

Individuals are encouraged to apply for the LPN program, which is housed in the Workforce Development Center. The program offers both classroom and hands-on learning experiences through practical internships at a variety of health-related facilities. The LPN program curriculum is delivered by a skilled staff and students have access to a contemporary lab simulating a real clinical environment.



About the School of Licensed Practical Nursing

The LPN program is equivalent to 16 months of study certified by the NJ Board of Nursing.

Training is provided to primarily low-income individuals and upon graduation, increase earning potential by **268%**.

The course is divided into teaching and clinical according to standards established by the Board of Nursing with 40% classroom instruction in theory and 60% clinical laboratory learning experiences. The clinical work is conducted at UMDNJ and students must pass the New Jersey Board of License NCLEX-PN licensure examination to Practice as a Licensed Practical Nurse in NJ.

Admission Procedure

Admission Requirements

Applicants must take a program entrance exam. The testing schedule can be obtained by calling 973-824-6484 or visiting the center at 201 Bergen St., Newark, NJ.

To apply for the program, candidates must provide;

- Two character references
- Submit OFFICIAL High School transcripts or proof of GED
- Proof of Mantoux tested within the last 12 months of enrollment
- Proof of a completed physical
- Attend financial aid information session

Upon successful completion of all course work, students are required to take the NCWDC Mandatory Review Course and successfully pass the practical nursing program NCLEX-PN on-line predictor tests. These two test must be completed prior to applying for the NCLEX-PN Licensure examination.
